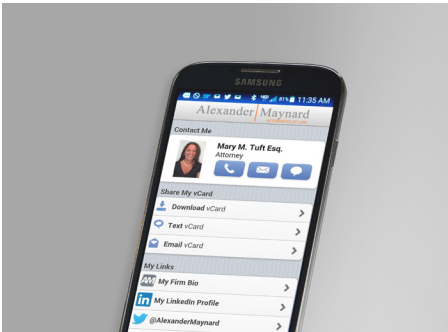

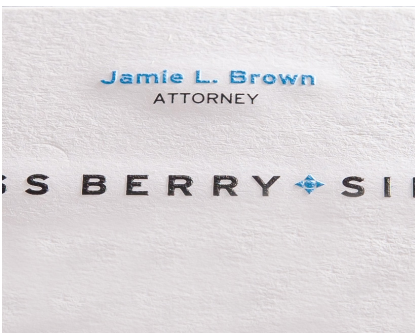

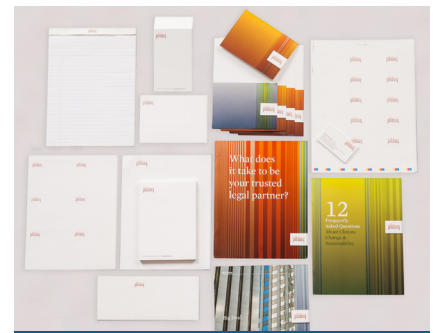

An ideal way to add emphasis to your pieces with a raised or depressed element. Perfect for logos, symbols, or seals.



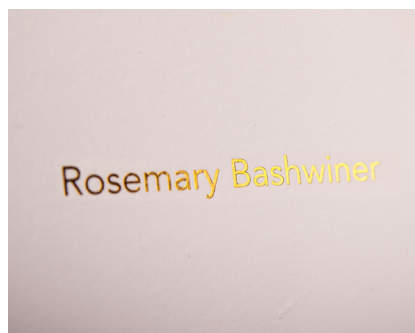

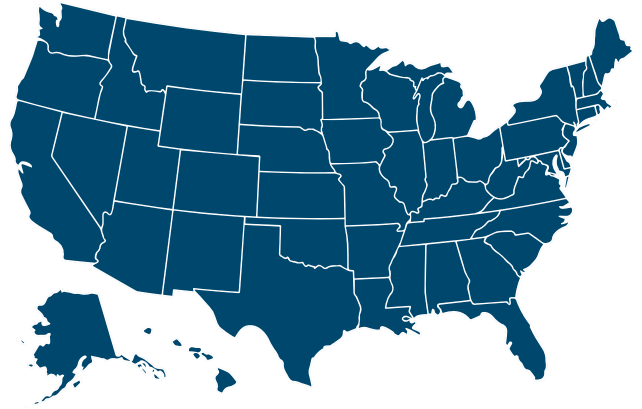
