# **Folder Imprint Area**



Standard position 31/2" from top, centered on front

Alternate positions: at least 1/4" from top or side edges

#### Notes:

- 1. Imprint cannot cross over the area 4" from the bottom due to inside pocket.
- 2. The maximum imprint copy area is 2" x 7" when imprinted on the bottom 4" of the folder. The maximum imprint copy area is 5" x 7" in other locations.




# **Custom Presentation Folders**




08-01 - Round corners / Two pockets


**08-04** – One right pocket only



**08-36** – Conformer® Expansion folder with fold down flap. Window and holes for fasteners are optional




**08-65\*** – Conformer® Expansion folder stays flat for a professional presentation \*window is optional




**08-29** – Square corners / Two pockets

**08-52** – Tuck tab / Can be used in horizontal or vertical format




**08-02** – 1/2" backbone allows for more capacity at spine

**08-11** – 1/4" backbone



# **Additional Options to Consider:**


- Legal size folders

**08-61** – Diagonal pockets




08-55 - Wrap-Around tuck tab / Also available with Velcro closure




08-13 - Two 1/4" capacity box pockets

08-53 - Regular left pocket, 1/4" capacity right box pocket


- Brochure slits ensure your smaller brochures stay in place

**38-01** – Three panels, three pockets


**38-04** – One right pocket only
